

1. **Eligibility:** The Arts Council Oklahoma City Opening Night Finale 5K Registration Fee Giveaway (“Sweepstakes”) is open to legal residents of Oklahoma twenty-five (25) years of age or older at the time of entry. Employees, officers, directors, agents, and representatives of Arts Council Oklahoma City, Parrish DeVaughn Injury Lawyers (“Sponsor”), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, the “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win.
